MAHARASHTRA REGIONAL AND TOWN PLANNING ACT, 1966.

No. BKR. 1177/262-UD-5.—Whereas, under the Government Notification, Urban Development, Public Health Department, No. BKR. 1177/262-UD-5, dated the 7th March 1977, the Bombay Metropolitan Region Development Authority (hereinafter referred to as the said Special Planning Authority) was appointed as the Special Planning Authority under sub-section (1) of section 40 of the Maharashtra Regional and Town Planning Act, 1966 (Mah. XXXVII of 1966) (hereinafter referred to as "the said Act") for the notified area of Bandra-Kurla Complex (hereinafter referred to as the said notified area);

And whereas, the said Special Planning Authority after following the procedure as laid down in sub-section (2) of section 115 as substituted by section 40(3) of the said Act, has after following the procedure prescribed therein submitted the planning proposals for the said notified area to the Government for its sanction on 18th October 1978;

And whereas, the Government of Maharashtra after carrying out enquiries and after consulting the Director of Town Planning, is of the opinion that the planning proposals as submitted by the said Special Planning Authority should be sanctioned subject to the modifications as specified in the schedule of modification appended hereto;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 115 as substituted by section 40(3) of the said Act and all other powers enabling it in that behalf, the Government of Maharashtra hereby sanctions the planning proposals as submitted by the said Special Planning Authority with modifications, as specified in the schedule of modifications.

Schedule of Modification

1. Land admeasuring about 0.82 ha. (9807 sq. yards) out of area zoned as residential and located to the east of site reserved for Hospital in Block "A" shall be designated for the purpose of "Hospital" and the site which is designated as "Hospital" together with the remaining area from Residential Zone to its east, shall be allocated for Residential user.

2. The Floor-Space-Indices prescribed in the D. C. Rules framed in these planning proposals shall not apply to the already developed areas for which no planning proposals are framed by the Special Planning Authority, and such areas shall continue to be governed by the floor space indices prescribed in D. C. Rules of Greater Bombay Development Plan.

Note.—The documents of the Planning Proposals as sanctioned by the Government of Maharashtra shall be available for inspection by the public in the office of the Bombay Metropolitan Region Development Authority, during working hours on all working days.
