Preface:

 For implementing the Slum Rehabilitation Scheme the State Govt. has amended the Maharashtra Slum (Improvement, Removal & Redevelopment) Act, 1971, Vide Notification No. SRS-1095 / M.No. 37 / Hsg. Cell dtd. 16/12/1995. Under clause 3 a (1) & (2) of said amended Act the State Govt. has constituted the Slum Rehabilitation Authority for Brihanmumbai. For the purpose of office work of the said Tribunal 10 departments have been formed under the administrative control of the Chief Executive Officer / SRA.
