## OFFICE ORDER

Sub:- Monitoring the S.R. Schemes pending in MMR, SRA.

As Considering Mumbai, SRA's Office Order dtd.16/03/2016, dtd.03/02/2021 and dtd.21/05/2021, the Chief Executive Officer, MMR,SRA has decided as follows;

In exercise of powers conferred under provision of Maharashtra Slum Areas (I.C. & R.) ACT 1971 the Chief Executive Officer, MMR,SRA is required to conduct hearings in respect of ongoing slum rehabilitation schemes and monitor/take review of progress in S.R. Schemes sanctioned/submitted to Mumbai Metropolitan Region Slum Rehabilitation Authority.

However, due to administrative exigency and with a view to streamline said process, and in exercise of powers u/s 3(S) of Slum Act, the said powers are hereby delegated to Secretary, Mumbai Metropolitan Region Slum Rehabilitation Authority with following directions;

- 1. The Slum Rehabilitation Schemes in respect of which the certified Annexure-II is not issued and the certified Annexure-II is received but LOI is not issued within one year of receipt of Annexure-II, the hearing in respect of non-performance/monitoring of Slum Rehabilitation Schemes including the Complaints u/s 13(2) of the Maharashtra Slum Areas (I.C. & R.) Act 1971 shall be conducted by the Secretary, Mumbai Metropolitan Region Slum Rehabilitation Authority, except in schemes where specific directions are issued by CEO/MMR,SRA/HPC/Court of Law and Competent Forum.
- 2. In respect of Slum Rehabilitation Schemes wherein the LOI is issued, the hearing will be conducted by Chief Executive Officer, Mumbai Metropolitan Region Slum Rehabilitation Authority.
