- 2. That you shall hand over the 524.27 sq.mtr. Road set back area (13.40 mtr. N.P. Road) to MCGM free of cost & free of encumbrances before reque ting CC to the last 25% for Sale BUA of sale building in the S.R. schem.
- 3. That yo i shall not claim the FSI benefit of the said CTS no. adjoining CTS no 369/18 (pt) & 369/71.
- 4. That you shall got acquire the land bearing CTS Nos 375 (pt) before requestin, CC to the last 25% for Sale BUA of sale building in the S.R. scheme.

- 5. That you shall submit slum declaration of the land bearing CTS No. 373(pt) before requesting CC to the last 25% for Sale BUA of sale building in the S.R. scheme.
- 6. That the Amenity Tenements i.e. 03 Balwadies shall be handed over to the Woman and Child Welfare Department, Government of Maharashtra as per the directions given by the Additional Chief Secretary, Woman and Child Welfare Department, Government of Maharashtra, in meeting held on 18.10.2011 and as per Circular No. 129 and 03 Welfare Centers, 02 nos. of Society Offices shall be handed over to the slum dwellers society to use for specific purpose only, within 30 days from the date of issue of OCC of Rehab/Composite bldg. Handing over / Taking over receipt shall be submitted to SRA.
- 7. That you shall submit the P.R. Card with area mentioned in words duly certified by Superintendent of Land Records for amalgamated/subdivided plots before requesting C.C. for last 25% of sale built up area.

If applicants Society/Developer/Architect are agreeable to all these conditions, then they may submit proposal for approval of plans separately for each building, in conformity with the modified D.C. Regulations of 1991 in the office of the undersigned within 90 days from receipt of this LOI.
