These Suo-Moto proceedings are initiated in respect of Slum Rehabilitation Scheme on land CTS No.1A(pt) of Village Deonar, for Respondent No.3 pursuant to the note of Deputy Collector (E.S.)/SRA dated 22.10.2018. The subject SR Scheme is accepted on 07.04.2006. The draft Annexure-II is forwarded to Competent Authority and till date certified Annexure-II is not issued. Since then there is no progress. The Slum Rehabilitation Authority has recorded 517 dormant proposals in

which the developers and societies have failed to take necessary steps. In said list of 517 schemes, the subject SR Scheme is at Sr. No.198. Since the proposal is already recorded through public notice dated 20.04.2022, the proceeding stands disposed of.
