- 2. That you shall execute a registered agreement to lease and lease deed as per SRA circular No, 195 vide No. CEO/SRA/LA/2020/459 dtd. 14/09/2020.
- 3. That you shall submit NOC from MCGM or Competent Authority before demolishing the toilet till that time the same toilet portion shall be kept in abeyance.
- 4. That you shall submit updated P.R. card with current owners name on CTS No. 5027, 5045, 5046, 5065 and making area correction on CTS No. 5045, 5046, 5065, within 06 months as per DSLR NOC.
- 5. That 02 nos. of structures are out of boundary, 07 nos. of structure where name is not given and 48 nos. of closed structures which are considered as residential user, in future if user changes developer/Architect will revise the LOI accordingly.

6. If the land under this scheme is belonging to Govt./MHADA/MCGM, the Public Authority is requested to grant NOC for the Slum Rehabilitation Scheme within a period of 30 days from the date of intimation of this approval, else the provision of clause No. 2.8 of Appendix-VII of Reg. 33 (10) of DCR-2034 is applicable.

If applicant Society/Developer/Architect is agreeable to all these conditions, then they may submit proposal for approval of plans separately for each building, in conformity with Regulations of DCPR-2034 in the office of the undersigned within 90 days from receipt of this LOI.
